

## **Voting and Annual Meeting**



Our Kenmure Community is quite a success story. We have distinctive, well-built homes in a lovely, wooded mountain setting. We have over twenty miles of well-maintained roads, each with carved wooden street signs. We have officers who secure our entrance gate, patrol our neighborhoods, and respond to emergencies. We have garbage pick-up, lawn service for common grounds and plowed roads in the winter. We have an office building and our own library. We are fiscally and financially well-managed. What is so surprising to many who live outside Kenmure is that all of this is the result of **Volunteers!** From those

Online instructions are included in your election notification email. It is <u>very important</u> that you return your <u>signed</u> proxy to ensure we have a quorum to hold our Annual Meeting. If you decide to attend the Annual Meeting, your proxy will be revoked and you will be able to vote to 1) approve the 2023 Annual Meeting Minutes, and 2) ratify the 2025 KPOA budget. Please note that the proxy applies only to the meeting quorum and for any meeting votes; it does NOT pertain to the election of board positions.

New Board members will be presented at the **ANNUAL KPOA MEETING on December 11, 2024.** Annual Meeting information will also be included in the Election Package.

#### **David Goins**

Below are excerpts of my original letter written before the storm because there's information you need to know concerning our upcoming Annual Meeting, the election of two Board members, and other details important for residents.

Kenmure is a special place to live, and we are thankful for the more than 150 volunteers who help make living here so enjoyable. Your KPOA board has 7 elected members and 3 appointed positions, and we have a staggered cycle of elected members serving 3-year terms. There are two board seats up for election this year and we have three qualified individuals to run for those two seats. Please take the time to review the candidate profiles found within this newsletter; and, if warranted feel free to reach out to each of them to know them better before casting your vote.

**Public Safety Announcement:** <u>SLOW DOWN</u> and please <u>STOP</u> at stop signs. I know we're all in hurry these days, to get to the grocery store, doctor's appointment or hair appointments, but is it worth the minute or two you save flying around Kenmure to break our road rules? We've had some fender benders, but luckily no major accidents have happened, and we want to keep it that way. Our Security team is doing their best to flag offenders, but it's up to all of us to police ourselves and drive safely. Keeping to the right of the yellow line is <u>always</u> the right thing to do as well. And don't fail to let your contractors know they too are expected to abide by our road rules!

If you haven't seen inside the KPOA office lately, you are going to be very pleased with the updated décor and changes we've made. The interior hadn't been updated in decades and it was past time for repairs and renovations. The project began with all new wiring, updated worn lighting and switches, removal of popcorn ceilings, all new paint on ceilings and walls, and new flooring. Unfortunately, as the project was moving along we discovered the hot water tank had been leaking and causing damage to both flooring and walls in the library area. Although the library wasn't budgeted for renovation, repairing the damage was essential.

As you know, not every hero wears a cape....and in this case, Office Building Maintenance Coordinator Bob Winans donned his toolbelt, rounded up additional volunteers and took on the task of fixing the walls, painting, and coordinating a game plan to refurbish the library. It was necessary to store more than one thousand books and completely remove the 500 feet of shelving. Bob's efforts, along with all the volunteers, saved thousands of dollars and made it possible for us to afford new flooring for the library. As of this writing a plan of action is being developed by other volunteers to rebuild all the shelving and have the library functional once again.

All residents received an email from your Security committee advising of the updated guidelines and process for visitor/contractor gatepass requests. While it has always been the responsibility of residents to enter this information, to allow personnel the time to better manage our security protocols and ensure the safety of residents we are now requiring all Kenmure residents (capable of using the online portal) to do so. Your board knows this requirement has been a sensitive issue for some residents, but to manage costs and control our security budget, we need your support to minimize "call in" visitor pass requests. We are thankful for your support and understanding in this matter.

I want to remind you to put our annual KPOA meeting on your calendar for December 11<sup>th</sup> beginning at 5:00 pm in the Charleston Room at the Club. At that time, we'll announce our new elected board members, and we will also recognize and thank Sally Hale and Fred Balling who are completing their terms on the Board. We are also looking forward to sharing pictures of the new KPOA office renovations and discussing future.

As always, the KPOA board welcomes your questions, suggestions and comments. Our committees are always looking for new faces to join their teams. Please don't hesitate to contact any of the board members or committee chairs if you have a desire to serve.

### **DIRECTORY UPDATE REMINDER!**

Is there false information about you or anyone in your household in the KPOA Directory? Probably not, but changes do occur so it is time once again to review your personal contact information currently on file with the KPOA Office.

To ensure your information will be correct and up-to-date in the 2025 Kenmure Directory, your information must be submitted no later than December 1<sup>st</sup>, 2024. No action is required if your current entry is correct.

To access the directory, go to <a href="www.kenmure.org">www.kenmure.org</a> and from the menu on that page, select <a href="KPOA Members Only">KPOA Members Only</a>. If you do not see that selection, click on the menu (3 bars) in the upper right corner of the page or scroll to the bottom and look under "Quick Links." Once you have accessed the Members Only page, enter the password (Kenmure.docs) and scroll down to then select <a href="Kenmure Online Real-time Directory">Kenmure Online Real-time Directory</a>. Enter your last name, select "View Profile" and review your information—remember, no action is required if your information is correct.

If an update is needed, click on "Back to Full Listings" then click on "Return to Members Only," scroll down to the "Directory Update Link" located just below Kenmure Monthly Online PDF Directory link. Hang in there, you are almost done...just click on the Update link, complete the form with any changes you wish to make; review your information and then click "Submit." If the changes apply to each member of the household, please submit a separate form for each person.

Your information (including any changes) will be reflected in the 2025 Kenmure Directory (published in February) as well as for the Annual Assessment Process — those invoices are emailed to households each January.

Don't forget--to have your correct information in the 2025 Directory, you must submit your information by December 1, 2024.

Realizing some residents may be having internet issues lingering from the hurricane, your KPOA Office Volunteers are happy to help. If you need any assistance making changes in your profile, please visit the KPOA office any weekday between the hours of 1 p.m. to 3 p.m.
