We are financially sound due to the guidance of our treasurer, Dale Seekely, and the diligence of the board and chairs to manage our operations in a prudent fiscally responsible manner. All major damage has been repaired except for a few culverts still needing work. Our Road Maintenance Committee has a handle on expected expenses to finish those concerns with the appropriate funding to complete the projects. Our reserves took a significant hit, but barring any future weather catastrophes, the board has begun plans to replenish those reserves next year.

Kenmure has been fortunate to have Dale as our treasurer the past 7 years. He has provided sound fiscal judgement and direction to the board and committees as well as served as a voice of reason at the board meetings. I'm sorry to say Dale has decided to step away from the treasurer's position at years end. Please give Dale a warm THANK YOU and a gracious appreciation for his services to the Kenmure community next time you see him. As announced at our mid-year meeting, Charlie Parks has stepped forward and will resume Dale's duties as the 2025 calendar year unfolds. Dale and Charlie have been working for a couple months on the transition and the board is pleased with the addition of Charlie to the board as our new treasurer.

November is the time for KPOA board elections. This year we have two positions open. We are fortunate to have board members wanting to continue their service to the community as well as new candidates that wish to bring their experience and energy to the board. I encourage every Kenmure resident to thoroughly review the candidates bios elsewhere in the newsletter and even reach out to each candidate to discuss their thoughts and passion to successfully move into this three-year commitment.

Last year the Elections Committee pushed everyone to use the electronic voting method instead of manual ballots. This was a huge success with the majority of votes being submitted electronically. Using electronic voting is more efficient and greatly reduces our costs. For those who don't feel comfortable voting electronically, the Elections committee will have voting booths set up at the KPOA office on November 8th and 22nd from 10 a.m.-- 2:00 p.m. I would urge as many of you who prefer to vote in person to do so on that first Saturday (11/8)—the more votes we can tabulate electronically, the fewer ballots we'll have to mail which will significantly reduce our costs since postage rates continue to escalate.

Amazon shoppers beware when ordering--please make sure you "DO NOT" request early morning (4-7 a.m.) delivery. The guards will not let deliveries through our gates that early. Unfortunately, the GPS used by independent drivers for Amazon for those early morning deliveries directs the driver to our Argyle gate. We have found over 20 packages left on the ground by that gate over the past few weeks.

The holiday season is fast approaching and there is a special occurrence brewing. Residents of Kenmure in coordination with Kenmure Country Club, will have a special Tree lighting of the huge Norway Spruce near the Top Tracer golf complex. Please mark your calendars for the evening of December 3rd, further details will be forthcoming.

The KPOA board, committee chairs and our 140+ volunteers look forward to continuing our efforts to maintain and expand on keeping Kenmure the best place to live in WNC. We look forward to seeing many of you at the KPOA annual meeting on December 9th beginning at 5:30 p.m., at the Kenmure Country Club.

ARE YOU BEAR-LY LIVING?

With the number of black bear sightings seemingly on the increase, KPOA has posted an Advisory Article on the www.Kenmure.org website with some important information and links where you can learn more about co-existing peacefully with them, what to do (and not do) if you encounter one or more and other helpful hints. Please take the time to learn more about our four-legged furry residents. In addition to the advisory article, here are a few things to keep in mind for the next couple of months: bears may be awake and searching for food up to 20 hours a day before their long winter's nap; some bears no longer take that nap if there is a dependable food source available--don't feed them; bears are typically more active at dawn or dusk as they forage for food so they may cross the road more often so stay alert while driving and if you have a passenger you might put them on wildlife watch; always keep dogs leashed when out walking; carry bear spray, know how to use it; and one last important point—leave your earbuds at home so you can hear them if they are nearby and periodically make noise so bears can avoid YOU!

There are several entertaining videos of wildlife in Kenmure posted on the KPOA website's Critter Report. You'll find those under Resident Info on the website. Check'em out! Living in the mountains gives us almost a daily opportunity to experience nature...some of it to enjoy and some to avoid!! It is incumbent upon us to educate ourselves and know which is which.

- **In-Person Voting**--Kiosks will be available to cast your vote and assign proxies at KPOA office on: Saturday, November 8th and Saturday, November 22nd - *Hours: 10 a.m. – 2 p.m. both days*
- **Mail-In Voting**--Paper ballots and proxies will be mailed only to property owners who do not respond to electronic communications by November 12th. Paper ballots must be returned to the Election Committee by December 3rd to be counted.

New Board members will be presented at the KPOA Annual Meeting, December 9th. The meeting notice, agenda, and proposed 2026 budget will be sent electronically.

Important: Please return your proxy to ensure we have a quorum for the meeting. If you attend in person, your proxy will be revoked, and you can vote directly on:

1. Approving the 2024 Annual Meeting Minutes
2. Ratifying the 2026 KPOA budget

The four candidates running for the two Board positions to be filled submitted answers to a KPOA questionnaire to allow you to better know them, their background and the talent they bring to serve on the KPOA Board. Bill Daleure

Q. Provide a brief background of your experience and skill set. **A.** Graduating from Purdue University with Mechanical Engineering degree and specializing in rocket and space propulsion systems, I worked on the Saturn Moon Project with McDonnell Douglas Missile and Space and Apollo 11 the first flight to land on the moon. I then explored other endeavors until I found my calling, Residential Real Estate Development. For 43 years I have built high rise condominiums from Atlantic City, NJ to Gulf Shores, AL. and developed over 25,000 home sites in the Charlotte, Raleigh, and Nashville metropolitan markets. In the development of new communities, I established dozens of new homeowner associations serving as president of each, am familiar with the regulations that govern them, managed all aspects of the associations and trained homeowners how to manage the association in preparation of transferring control. I served as the President of Crosland Land Develop Company until forming my own firm

Avant-Garde Real Estate Consulting Inc. in 2010. **Q. Describe your volunteer experience including within the Kenmure community.** **A.** I am currently serving my third year on the KPOA Board and seventh year on Kenmure's Architectural Review Committee responsible for approving and tracking new home construction. **Q. How long have you lived in Kenmure?** **A.** My wife Linda and I moved to Kenmure 10 ½ years ago from Charlotte, NC. **Q. What are your objectives and priorities if you are elected to the board?** **A.** Continue Kenmure as the premier community in WNC through, maintaining high design standards, assisting all owners in working through the new home approval process, budgeting to maintain the annual dues as low as possible and solving problems as presented to the Board. I would like to continue as your representative on the KPOA Board using my experience to improve our community. **Q. Q. Provide a brief background of your experience and skill set. **A.** I worked for 10 years as a CPA with one of the big national accounting firms. Then I became Treasurer & CFO of the Pennsylvania Manufacturers Association and its related insurance companies. The PMA was active in Pennsylvania politics. The insurance operation was the largest Worker's Comp. insurer in the state and serviced most of the Mid-Atlantic. We had close to a billion in revenues and over 3 billion in assets. I retired from there in 1996. **Q. Describe your volunteer experience including within the Kenmure community.** **A.** I served as president of the Philadelphia Chapter of the Financial Executives Institute. I was active in our church in Radnor. I served as an official in the local swim league. Shortly after moving to Kenmure, I volunteered for KARC. After a bit, the KPOA treasurer persuaded me to replace him and I served as KPOA treasurer for 6 years. **Q. How long have you lived in**

Kenmure? **A.** 14 years as a full-time resident. **Q. What are your objectives and priorities if you are elected to the board?** **A.** Kenmure is a wonderful place to live. Some of the reasons why are because it is very well maintained, has building & grounds standards that are enforced, provides first class services like our trash removal and security guards and does not allow deforestation. Since my retirement, I have been a member of SCORE for the past 11 years where I continue to provide mentoring/counseling to small business owners as well as presenting seminars on the requirements for starting and operating a successful small business. During my residence in the Asheville area, I served as the Treasurer of my HOA for 4 ½ years. In honor of the Romeo family and the gentleman who took care of Kenmure and its residents for more than three decades, below is the loving tribute to Denis—Kenmure's first Security Guard who is remembered for his faithful service, cheerful personality and willingness to always go the extra mile for any resident. Sincere condolences to the Romeo family and all who knew and loved Denis.

IN LOVING MEMORY OF DENIS ROMEO DECEMBER 30, 1954 – JULY 14, 2025

With deep respect and affection, we remember Denis Kevin Romeo, who dedicated more than three decades to Kenmure Country Club, shaping not only the security of our community, but the spirit of it. Denis passed away peacefully at his home in West Palm Beach, Florida, on July 14, 2025, surrounded by his loving family, after a brief and sudden battle with pancreatic cancer.

Denis' connection to Kenmure ran deep. His father, Vincent Romeo, founded the Kenmure community in the 1970s, and Denis was there from the very beginning. Long before the clubhouse became the clubhouse, Denis called it home. He began with maintenance, then stepped into a role that would define his career: Head of Security Relations. For 32 years, Denis served Kenmure with integrity, compassion, and unwavering dedication.

Residents recall Denis not just as a gatekeeper, but as a friend, helper, and source of comfort. He ferried stranded neighbors through snow, found lost pets, checked on homes, administered CPR when needed, and greeted everyone with kindness and good humor. He believed that respect should be shown to all—residents, contractors, and visitors alike—and it showed in every interaction.

In 2013, as Denis prepared to retire and move to Cary, NC to be with his family, the community came together in an unforgettable farewell. Over 400 residents filled the clubhouse and lined the parking lot to celebrate the man who had become part of their daily lives and their hearts. His retirement marked the end of an era at Kenmure, but his legacy has never faded.

Denis's spirit of generosity extended far beyond his job description. He was an avid participant of the annual fundraiser for the Henderson County Hunger Coalition, walking 10 miles each year and inspiring the community to contribute. Over 14 years, Denis helped raise over \$347,000—yet another testament to how deeply he cared for others.

Born in Elkhart, Indiana, Denis spent his early years between Europe and the U.S., eventually earning his degree from Hillsdale College. He was a man of faith who read his Bible daily and lived by it, offering prayers, visiting those in need, and always making time to lift someone's spirits with a joke or warm word. He was also an avid athlete—tennis, basketball, and in recent years, pickleball.

Denis is survived by his wife of 38 years, Cookie, his son Adam and daughter-in-law Cynthia, and his grandson Raylan—his pride and joy. He also leaves behind siblings, extended family, and countless friends, colleagues, and Kenmure residents whose lives he touched.

As we reflect on his life, we give thanks for Denis Romeo—a man whose humor, humility, and compassion defined a community. His memory lives on in the hearts of all who knew him.

We extend our heartfelt condolences to his family and those closest to him. May his memory continue to be a blessing.

IT'S THAT TIME OF YEAR....AGAIN!

Here are just a few reminders as we enjoy the beauty of Fall....

- **September is Emergency Preparedness month.** If you have not prepared your “go bag,” or a list of items to consider taking with you should an evacuation become necessary, please go to our KPOA website (www.kenmure.org) where you will find an Emergency Preparedness list posted website under the Emergency Management Committee (EMC) tab. Below is the link : <https://kenmure.org/wp-content/uploads/2024/01/Evac-Disaster-Preparedness-List.pdf>

In the event of an evacuation, being prepared will aid you in being able to leave quickly and will also ensure you have all the essential documents, medicines, supplies, etc., necessary in the unlikely event of a lengthy stay elsewhere.

- **Fall clean up and wildfire prevention:**
 - ✓ According to the Henderson County Fire Marshall, the prime times for wildfires occurring in our area are spring and fall.
 - ✓ Check to see that your gutters and roof valleys are free of debris, leaves, pine needles, etc.
 - ✓ When raking or blowing your leaves and picking up small brush or twigs, dispose of them properly. Do not leave them in piles in your yard or in the right of way.
 - ✓ Keep in mind that burning leaves and brush is never allowed in Kenmure.
 - ✓ If you have firewood be sure you stack it at least 30 feet away from your house.
- **Planning to do some landscaping this fall or spring?** Become familiar with the contents in the “Fire- Resistant Landscaping in North Carolina” pamphlet posted on the KPOA website under the EMC tab. <https://content.ces.ncsu.edu/fire-resistant-landscaping-in-north-carolina>
In the pamphlet you will find a number of ideas in regard to fire-resistant plants and shrubs that you may be interested incorporating into your landscaping project.

Illegal Activity in Kenmure?

Probably not. However, if you proudly display the Flag of the United States of America and aren't following the National Flag code, you might be breaking the law. There are a number of flags permitted to fly in Kenmure but "Old Glory" is the only one that has its own Flag Code—deemed a federal law in 1942—detailing specific ways to display and respect it. Before listing some of the do's and don'ts, did you know the original flag,



created in 1777, has undergone 27 design versions? Though the design has been portrayed differently over the years, the stars and stripes have remained unchanged through each version. In 1959, there was a contest for a new flag design that would represent how the country had grown. The current 50-state flag design was submitted by a 17-year-old and chosen by President Eisenhower from over 1,500 other submissions. Thus, the design we fly today is the longest running iteration of our American pride and the freedom we hold dear.

While the Ragged Old Flag may have been a hit recording for country music icon Johnny Cash, a flag beyond repair is never to be displayed anywhere. The proper disposal for our flag is to burn it and its ashes buried, and since there is no burning in our community you should contact the local VFW or a fire station for help if you have a U. S. Flag in poor condition. Below are important do's & don'ts for displaying a U.S. Flag:

- Traditionally should only be displayed from sunrise to sunset; with proper illumination can be displayed at night IF the flag light is a dedicated light source ensuring the entire flag is visible and free from shadows (not streetlights, porch lights, etc.)
- Avoid subjecting the flag to harsh weather conditions at all times.
- When hanging vertically the blue union should always be in the upper left position.
- If not displayed on a staff, should be suspended where its folds fly free; when displayed on a wall, horizontally or vertically, the union stars should be in the flag's upper right hand corner.
- When displayed in a window ensure the union stars are to the left of an observer in the street.
- The flag should never touch the ground, floor, water or anything beneath it (chairs, swings, porch railings, etc.)
- Do not fasten it or tie it back, it must always be allowed to fall free.

More than just the cloth or the colors or the stars we see, Old Glory is a representation of our country and embodies the principles, history, those who have fought and died for our freedoms and the people who make the United States what it is. The Flag is a symbol of our nation's freedom and while we are patriotic, let's strive to respect and honor—legally--all she has symbolized from our nation's very beginning.
